



## School Parent and Family Engagement Policy Elementary

- *Parent and family engagement means the participation of parents in regular, two-way and meaningful communication involving student academic learning and other school activities,*

*including ensuring:*

- *Parents play an integral role in assisting their children's learning;*

- *Parents are full partners in their children's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their children; and*
- *Other activities are carried out, such as those described in Section 1116 of ESSA.*

- The "Annual Title I Meeting" will be held in the fall before November 20th.
- The Parent-Teacher Organization will meet monthly throughout the school year.

### **Communications**

**PES** will take the following actions to provide parents of participating children the following:

- Timely information about the Title I programs;
  - Flexible number of meetings, such as meetings in the morning or evening, and may provide with Title I funds, transportation, child care or home visits, as such services relate to parent and family engagement; and
  - Information related to the school and parent programs, meetings and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents can understand.

  - The state and local academic assessments, including alternate assessments;
  - The requirements of Title I, Part A;
  - How to monitor their children's progress; and

- The *State Assessment* results will be sent home with the last grade card.
- Providing an annual Title I meeting for all parents.
- Monthly Parent Newsletters
- Fall and Spring Parent-Teacher Conferences
- “Early Years” sent home for each Pre-school and kindergartener.
- “Home and School Connection” sent home monthly for 1st – 6th grade.

□ **Building Capacity of School Staff**

PES will provide training to educate teachers, specialized instructional support personnel, principals and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents and in how to reach out to, communicate with and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

- Professional Development during the monthly staff meetings, and staff “In-service” days.

PES will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:

- The principal will respond to any such questions, suggestion and issues as soon as possible.
